## By-Laws

#### **ARTICLE I**

#### NAME

The name of this organization shall be "Christ the King Council of Catholic Women" of Christ the King Church and it shall be located at Jacksonville, Florida.

#### **ARTICLE II**

#### **OBJECT**

The object of the organization shall be:

- 1) To develop spiritual and social life among the members of Council, parishioners and community.
- 2) To sponsor parish projects that benefit the parish, as agreed upon by the Council and the Pastor.
- 3) To participate in community activities.

#### **ARTICLE III**

#### **MEMBERSHIP**

Section 1: Any woman interested in the preceding objectives is eligible for membership. Section 2: There shall be three (3) types of membership: Active, Inactive and At large and Honorary.

Section 3: Annual dues for Active and At-Large membership shall payable by May 31st of the fiscal year. The amount will be determined by the Christ the King Council of Catholic Women Executive Board.

#### **ARTICLE IV**

#### **OFFICERS**

Section 1: (a) Officers of this organization shall be: President, Vice-President, Recording Secretary and Treasurer and shall be known as the Executive Board.

(b) A Corresponding Secretary, Parliamentarian and Spiritual Moderator shall be appointed by the President.

Section 2: At the September Council Meeting, a Nominating committee of five (5) members shall be appointed by the Council President to serve for one (1) year. The Nominating Committee shall elect from themselves a Chairman and Co-Chairman. This committee shall prepare a slate containing a name for each elected office and shall report same at the January meeting. This does not preclude nominations from the floor at this meeting. If there are no further nominations, the Slate will be elected by acclamation at this meeting. Should there be further nominations, a general meeting will be called in March and the election will be held at that time.

### Christ the King Council of Catholic Women

Section 3: Vacancies in the Executive Board shall be filled by the Nominating Committee with the approval of the Board of Directors.

Section 4: The officers shall be elected at the January or March meeting and take office in May. All officers shall be elected for one (1) year, with the option for a second year.

Section 5: All elected officers shall be Catholic and active members of CKCCW.

#### **ARTICLE V**

#### **DUTIES OF OFFICERS**

Section 1: The President shall preside at all General and Board Meetings, shall appoint and be ex-officio members of all committees/commissions, except the Nominating Committee. She shall have general supervision of affairs of the Council and perform such other duties as pertain to the office of the President.

Section 2: The first Vice President shall assist the President in her official duties and perform the duties of the President in her absence. She shall be Membership and Hospitality Chairman.

Section 3: The Recording secretary shall keep an accurate record of all General and Board Meetings. She shall perform such other duties as pertain to her office. In the absence of a circle representative the Board Meeting, she shall mail a copy of the minutes to that Circle Chairman.

Section 4: The Treasurer shall be responsible for the receipt of all monies and pay all authorized bills. She shall make monthly reports of the condition of the treasury. All books shall be audited before a new treasurer takes office.

Section 5: The Corresponding Secretary shall be responsible for all correspondence pertaining to the Council.

Section 6: The Parliamentarian shall be responsible for adherence to this Council's by-laws.

#### **ARTICLE VI**

#### MEETINGS

Section 1: The general meetings of the Council shall be held the last Thursday of the month in September, January and April. Other meetings may be called at the discretion of the Board. Officers must attend all general meetings unless excused by the President.

Section 2: Special meetings may be called by the President.

Section 3: Vote will be with the majority of the membership present.

Section 4: Board Meetings shall be held the First Monday of each month, unless otherwise ordered by the President. Officers elected and each appointed Circle Chairman or their representative must attend.

#### **ARTICLE VII**

#### **EXECUTIVE BOARD**

Section 1: The elected officers of the Council, the Spiritual Moderator, the Corresponding Secretary, and the Parliamentarian shall constitute the Executive Board.

Section 2: The Executive Board shall meet prior to the September Board of Director's Meeting.

Section 3: Four (4) members of the Executive Board shall constitute a quorum for the transaction of business.

#### **ARTICLE VIII**

#### **BOARD OF DIRECTORS**

Section I: The Board of Directors of the council shall be the Executive Board and the Chairman from each Circle or her representative.

Section 2: The Board of Directors shall meet the First Monday of the month from September to May inclusive unless otherwise ordered by the Executive Board.

Section 3: Four (4) officers and five (5) representatives of the circles shall constitute a quorum for the transaction of business.

#### **ARTICLE IX**

#### **DIOCESAN & DEANERY COUNCIL REPRESENTATION**

Section 1: The newly elected President shall serve as a delegate to the St. Augustine DCCW Convention. The newly elected Vice-President shall be the alternate delegate. Expenses of either the delegate or the alternate shall be paid by the Cuncil. In the event neither is able to attend, replacement shall be made by the Executive Officers according to rank.

Section 2: The Vice-President or an appointed alternate shall serve as delegate to the spring meeting of the South Jacksonville Deanery. Expenses of the delegate shall be paid by the Council.

#### **ARTICLE X**

#### **COMMISSIONS & COMMITTEES**

Chairman of Commissions and Committees as suggested by the St. Augustine DCCW, shall be appointed at the discretion of the President.

#### **ARTICLE XI**

#### PARLIAMENTARY AUTHORITY

Roberts Rules of Order, Newly Revised, shall be the authority of the Council in all matters not covered by these by-laws.

#### **ARTICLE XII**

#### **AMENDMENTS**

These by-laws may be amended at any general meetings by a two-thirds (2/3) vote of the members present and voting, provided that previous notice has been given to the membership of the intention to amend.

#### **ARTICLE XIII**

#### **CIRCLE RULES**

Section I: A Chairman shall be elected by the members of the Circle at the regular March meeting and shall be installed with the Council Officers in May. She shall select a co-chairman to assist her in her duties. Other officers shall be elected by the Circle members, as deemed necessary by the members. The Chairman shall appoint committee/commission chairmen as required or deemed necessary.

Section 2: The Chairman or her representative shall attend all Council meetings, Board meetings, and special or called meetings. The Chairman as a part of the Board is representative of the circle and as such will make decisions in their behalf.

Section 3: The Chairman shall urge all Circle members to participate in First Saturday devotions and all Council meetings and activities.

Section 4: Circles are to support all Council projects by their attendance and financial assistance.

Section 5: Circles may sponsor as many projects as they wish to raise money for the Council.

Section 6: Each Circle shall take its turn as hostess at Council activities when requested to do so.

Section 7: Each Circle is requested to conduct its own Circle devotions.

Section 8: Each Circle chairman shall submit names of new members to the First Vice-President to help keep a correct and accurate list of members.

#### **ARTICLE XIV**

#### AT-LARGE MEMBERS

Section 1: Women who might not have the time to fully participate but want to belong to the Council and join in the activities if possible, may become At-Large members.

Section 2: At-Large members are to support Council projects by their attendance and financial assistance.

Section 3: Honorary members are long-time members who are no longer able to participate.

#### **ARTICLE XV**

All monies disbursed from the CKCCW Treasurer are to come to the Board at the monthly Board meeting by vote or have the verbal approval of three (3) Executive Board Members prior to disbursement.
